



## Camp Rules

At STEM Camp and FINE ARTS Camp, we not only want our campers to learn key Christian values, but also to have fun. In order for everyone to have a good time and be safe, we must have rules. Our campers are expected to follow the three R's:

- **Respect the Leaders. (No talking back, be obedient, etc.)**
- **Respect Others. (No using bad language, fighting, making fun of, etc)**
- **Respect the Property. (Notify leaders if things are broken or torn, no stealing, clean up your mess, etc)**

### Consequences for minor misbehaviors:

1. First offense – Warning
2. Second offense – Conference with team leader
3. Third offense – Time out and/or (writing assignment for older campers) Notify camp director.
4. Fourth offense – Notify Parent/Guardian
5. Fifth offense – Director's choice (The camp director will decide on the appropriate punishment ranging from probation, meeting with parent, and/or loss of privileges or participation in some camp events).

### Serious Misbehavior – The following requires notification of camp director immediately:

- Foul Language
- Bullying
- Fighting
- Inappropriate physical contact
- Obscene gestures
- Stealing
- Willful destruction of property

In cases of recurring misbehavior, parents will be contacted so that we may work things out together. If the misbehavior continues, (i.e.: fighting, leaving your counselor, cussing, bullying, and being rude/disrespectful) the Director/Assistant Director will meet with parent, the counselor, and the camper, and place the child on a week's probationary time. If the behavior does not improve, the parents will be called and the camper will be given a 2 day break from camp (no refunds for misbehavior). Upon returning to camp, if behavior occurs again, the parents will be asked to withdraw their child from camp immediately.

**\*Note: If your child has any special needs, (ie: autism, hyperactivity) please notify the camp director.**
